# Thorsby helps local girl attend Space Camp

Huntsville, AL – Calli Blanchette of Thorsby, AB recently attended Space Academy at the U.S. Space and Rocket Center, home of Space Camp®, Space Camp® Robotics $^{\text{TM}}$ , Aviation Challenge® and NASA Marshall Space Flight Center's Official Visitor Center.

The weeklong educational program promotes science, technology, engineering and math (STEM), while training students with hands-on activities and missions based on teamwork, leadership and problem solving.

This program is specifically designed for trainees who have a particular interest in space exploration. Blanchette spent the week training with a team that flew a simulated space mission to the International Space Station (ISS). Once aboard the ISS, the crew participated in experiments and successfully completed an extra-vehicular activity (EVA), or spacewalk. Blanchette and crew returned to earth in time to graduate with honors.

Space Camp operates year-round in Huntsville, Alabama, and uses astronaut training techniques to engage trainees in real-world applications of STEM subjects. Students sleep in quarters designed to resemble the ISS and train in simulators like those used by NASA.

More than 750,000 trainees have graduated from Space Camp since its inception in Huntsville, Alabama in 1982, including European Space Agency astronaut, Samantha Cristoforetti and NASA astronauts Dottie Metcalf-Lindenburger, Dr. Kate Rubins and Dr. Serena Auñón, who recently launched to the International Space Sta-

tion. Children and teachers from all 50 states and 69 international locations have attended a Space Camp® program.

Practicing simple #SummerSafety tips can help

ensure that all road users have a safe and enjoyable Heritage Day long weekend.

- · Always apply the same sensible safety rules to all vehicles, including recreational ones: Drivers and riders alike should wear vehicle-appropriate safety gear such as a seatbelt, helmet and jacket.
- · Keep your eyes and attention on the road: Avoid distracted behaviour such as talking on a cell phone, texting, reading a book, eating, attending to other passengers or pets and personal grooming. Distracted operation of a vehicle increases the risk of collisions.
- Don't drink and operate a vehicle or boat: Drinking and driving laws apply equally to the operation of vessels on waterways as they do to motor vehicles on highways. In 2017, there were 18 instances of impaired operation of a boat and three boating collisions in Alberta RCMP jurisdiction.
- Do not adopt aggressive driving habits: Speeding, tailgating, cutting off other drivers, road raging and stunting are behaviours that put you and other road users at risk.

Supt. Rick Gardner, Alberta Traffic Sheriffs, says, "Distracted and aggressive driving are both as dangerous as impaired driving. We remind Albertans, especially young drivers and riders, to always remember that getting behind wheels is a serious responsibility."

#### OF THE TOWN OF THORSBY

(hereinafter referred to as "the Municipality")

#### IN THE PROVINCE OF ALBERTA

This bylaw authorizes the Council of the Town of Thorsby to incur indebtedness by the issuance of debenture(s) in the amount of \$929,148 for the water line replacement 52 Street to 53 Street, 53 St Cul-de-sac, 47 Ave and South, Hankin Street and 48 Avenue within the Town of Thorsby Municipal limits

WHEREAS:

The Council of the Town of Thorsby has decided to issue a bylaw pursuant to Section 258 of the *Municipal Government Act* to authorize the financing, undertaking and pavement replacement within the Town of Thorsby.

Requests for proposals have been submitted and specifications have been prepared and the total cost of the project is estimated to be \$929,148 and the Municipality estimates the following grants and contributions will be applied to the project:

Capital Reserves	\$000,000
Provincial Grants	\$000,000
Debenture(s)	\$929,148
Total Cost	\$929,148

In order to complete the project, it will by necessary for the Municipality to borrow the sum of \$929,148for a period not to exceed 20 years, from the Alberta Capital Finance Authority or another authorized financial institution, by the issuance of debentures and on the terms and conditions referred to in this bylaw.

The estimated lifetime of the project financed under this bylaw is equal to, or in excess of 25 years.

The principal amount of the outstanding debt of the Municipality at Dec 31, 2017 is \$1,484,034 and no part of the principal or interest is in arrears.

All required approvals for the project have been obtained and the project is in compliance with all Acts and Regulations of the Province of Alberta.

#### THEREFORE, THE COUNCIL OF THE TOWN OF THORSBY DULY ASSEMBLED, ENACTS AS FOLLOWS:

- 1. That for the purpose of purchasing municipal water line replacement the sum of NINE HUNDRED AND TWENTY-NINE THOUSAND AND ONE HUNDRED AND FORTY-EIGHT DOLLARS be borrowed from the Alberta Capital Finance Authority or another authorized financial institution by way of debenture on the credit and security of the Municipality at large, of which amount the full sum of \$929,148 is to be paid by the Municipality at large.
- 2. The proper Officers of the Municipality are hereby authorized to issue debenture(s) on behalf of the Municipality for the amount and purpose as authorized by this bylaw, namely the water line replacement.
- 3. The Municipality shall repay the indebtedness according to the repayment <u>structure in effect, namely semi-annual payments of combined principal and</u> interest instalments not to exceed TWENTY (20) years calculated at a rate not exceeding the interest rate fixed by the Alberta Capital Finance Authority or another authorized financial institution on the date of the borrowing, and not to exceed FIVE (5) percent.
- 4. The Municipality shall levy and raise in each year municipal taxes sufficient to pay the indebtedness.
- 5. The indebtedness shall be contracted on the credit and security of the Municipality.
- 6. The net amount borrowed under the bylaw shall be applied only to the project specified by this bylaw.
- 7. This bylaw comes into force on the date it is passed.
