Volunteer Income Tax Program

The **Community Volunteer Income Tax Program** is now completing 2020 income taxes free-of-charge for people with low to modest income and a simple tax situation. This can include seniors, students, social assistance recipients and newcomers to Canada. The volunteer program does not complete returns for people who are deceased, bankrupt, or have business, farming or rental income. Assistance to complete past year tax returns is also available.

In order to be eligible to receive the **Guaranteed Income Supplement**, **GST Tax Credit**, **Canada Child Benefit**, **Canada Workers Benefit or the Climate Action Incentive**, your 2020 tax return must be filed. Income taxes are due by April 30.

World Day of Prayer From Ebeline Zee-Hawtin

This year the World Day of Prayer is scheduled for Friday, 5th of March, 2021. Normally the service would have been held at St. Matthew's Lutheran Church in Thorsby, but with the gathering restrictions that is not possible. However, a service has been made available by the Women's Inter-Church Council of Canada and is available as a video on their web site. It can be viewed on www.wicc.org from now until September.

This year the host country is the Republic of Vanuata, a small country of islands located in the South Pacific Ocean north-east of Australia. Its black and white sandy beaches, coral reefs with coloured fish, tropical birds, fruits and nuts, make the islands a pristine environment, even though they are vulnerable to frequent earthquakes, cyclones and active volcanoes. Melanesian people, along with Polynesian, are the primary source of Vanuata's culture and languages. The Republic was formed in 1980 from a French and British joint government. Today, Vanuata proudly waves its flag and its coat of arms which reads "In God we Stand." The theme for this year is "Build on a Strong Foundation."

The World Day of Prayer is a global ecumenical movement which brings Christians of many traditions together to observe a common day of prayer each year. Through preparation and participation in the worship service, we can learn how our sisters of other countries, languages and cultures understand the Biblical passages in their context. We can hear their concerns and needs and can join in solidarity with them as we pray with and for them. In this way, it is possible to enrich our Christian faith as it grows deeper and broader in an international, ecumenical expression.

The motto of the World Day of Prayer movement is Informed Prayer and Prayerful Action. Through our participation in the World Day of Prayer, we affirm that prayer and action are inseparable and that both have immeasurable influence on the world.

The World Day of Prayer traces its roots to the 19th century when Presbyterian women in the United

States called for a national day of prayer in 1887, and Anglican women in Canada established a national day of corporate intercessions for mission in 1895. In 1922, the Canadian and U.S. committees agreed to use the same theme and day for the Day of Prayer as U.S. women. This annual event became the Women's World Day of Prayer in 1927; in recent years it has been named World Dav of Prayer although Women's Committees in the host countries continue to prepare the service to be used throughout the world. The Canadian committee is the Women's Inter-Church Council of Canada (WICC) and now includes representatives from 11 church partners. The WICC also distributes grants up to \$5,000 to fund social justice community projects.

The COVID-19 pandemic has brought out creativity in the most surprising ways. As fall trudged into winter, Grandview Beach (south side of Pigeon Lake, near Lakedell) resident Corey Kozack realized that there was a need in his community and he used his creativity to fill it.

Building skating rinks on Pigeon Lake is a long standing tradition for those living along its shores, but with the current situation keeping everyone a lot closer to home for the winter, Mr. Kozack realized that these rinks were leaving out a large segment of the community - seniors. Corey decided to remedy this situation and his solution was to build a curling rink on the lake. Not being a curler himself, Corey had a lot to learn about the process but with a little help from the internet and the community, he was able to create something special. He soon enlisted the help of friend and neighbour, Darcie Carey, to bring the vision to life.

Curlers know that ice is arguably the most important element of the sport. Quality ice for curling is even more important than that for skating or hockey and, fortunately, this year has been relatively successful for ice forming on the lake. Despite the superior conditions, Corey still regularly floods the sheet and heads out to refresh the pebbling on a routine basis to maintain a good surface.

The sheet truly has been a community effort with Crystal Springs resident Gloria Olson offering the use of a set of rocks for use by the players. Her rocks even include one signed by Alberta curling legend, Kevin Martin. Additionally, Loretta Wisenberger has made some homemade 'rocks' out of coloured water frozen in milk jugs for younger curlers to try their hand at sliding out of the hack. Scoring sticks were made to ensure the competitive curlers can keep track of their progress. Originally straw bales were set out to offer a place to take a rest between ends, but thanks to a generous donation from Lakeside Custom Woodwork, wooden benches are now installed. Neighbours from the area take turns shoveling both the sheet of curling ice and the nearby skating rink, making this a real community project. There is also a firepit available for use at Grandview Park so people can make a day of their experience out on the lake.

The 150 foot by 15 foot sheet of ice can be booked by reaching out to Corey on Facebook or calling him at 780-868-1475, and he has people coming out well into March, provided the conditions hold. Prior to each booking, Mr. Kozack and Mr. Carey prepare the ice by spraying water to refresh the critical pebbles for a good game. They also sanitize all the rocks and set them out for use. At the completion of the booking, the rocks are again sanitized to comply with all COVID restrictions. Those using the ice are asked to observe the restrictions as well, and to make sure they are being respectful of the natural environment by taking out anything they bring in at the end of their time on the ice.

Corey has been very pleased with the response to his project. Users of the ice have ranged from teenagers to octogenarians and everyone in between. He has learned plenty over the course of this season and is already planning on making this an ongoing feature next to the Grandview skating rink, which he has also been involved with maintaining over the past several years. Mr. Kozack is a very community minded person. He is also involved in creating the Haunted Barn during Halloween and organizing the Sledz and Treadz Fundraising Rally taking place on February 27. He hopes that everyone gets a chance to try their hand on the roaring rings before they melt!

The COVID-19 pandemic has changed everything about our lives. From whom we see to how we work, shop and learn, every single one of us has been impacted in one way, shape or form. That is why Alberta's government has taken action to protect the lives and livelihoods of Albertans as they continue to grapple with the COVID-19 pandemic.

Early in the pandemic, we recognized that social distancing guidelines and financial stress could have adverse effects on the mental health and wellbeing of Albertans. That is why we made a \$53 million investment in mental health and addiction supports to make sure Albertans who were in crisis would get the help they need.

We also took action to protect Alberta's most vulnerable, including those living in congregate living facilities. In May 2020, Alberta taxpayers invested more than \$170 million in funding to help keep residents and staff in long-term care, designated supportive living facilities and seniors' lodges safe. Knowing that seniors are at high risk from COVID-19, this funding helped us continue to protect our most vulnerable and allowed for facilities to enhance staffing and purchase additional PPE and cleaning supplies.

As part of Step 1 of Alberta's four-step framework to ease restrictions, we are taking a cautious approach as we look to ease restrictions impacting the day-to-day lives of Albertans. All the activities still have associated guidelines to ensure the safety and well being of Albertans, and we continue to monitor data to ensure that any steps we take to reduce restrictions on Albertans continue to protect their lives. While vaccines offer some hope of a return to normal, ongoing delivery delays from the federal government mean reasonable public health restrictions must remain in place. That is why Alberta's government has continued to take steps to protect the livelihoods of Albertans. We recently announced the Enhanced COVID Business Benefit, a new program that provides financial relief to those businesses whose bottom lines have been most affected by public health measures. Providing additional support to our small businesses means Alberta's job creators can continue to pay their employees, so they in turn can continue to support their families. We have also provided income support for people unable to work while they self-isolate, and provided support for daycares and day homes so childcare is not a barrier for those who are still able to work.

Applications for the Critical Worker Benefit also recently opened on Feb. 17. This benefit was launched to recognize hundreds of thousands of critical workers who continue to support and provide services to Albertans during this pandemic, and workers in health care, social services, education and in some parts of the private sector are eligible to receive this one-time payment.

We have also made significant investments in infrastructure projects. Accelerated schools, roads and other construction projects have helped us get more Albertans back to work while also moving ahead on important projects for communities across the province.

While life has changed significantly over the past year, Alberta's government continues to work hard to support you every single day. As the pandemic continues and we move forward on vaccinations, we will continue to do everything we can to protect both your lives and your livelihoods.




