

CENTRAL ALBERTA RCMP **CRIME REDUCTION UNIT ARREST MALE IN STOLEN** VEHICLE RESULTING IN **NUMEROUS CHARGES**

Buck Creek, Alta. - On. Jan. 19, 2022, the Central Alberta District Crime Reduction Unit (CAD CRU) was working in the Breton/Thorsby area on an unrelated investigation when investigators identified a stolen pickup truck, which had been stolen from a business in Warburg, AB the day prior, travelling in the Buck Lake area on Highway 22.

Road conditions were extremely poor, however with the assistance of the RCMP Helicopter, the suspect vehicle was monitored until it stopped at a business in Breton, Alta., where the driver identified as Logan Davis (26) of Breton, was arrested without incident by the members of CAD CRU, with assistance from the Thorsby/Breton RCMP.

As a result of the investigation, Davis has been charged with:

- Possess stolen property over \$5000
- Dangerous driving
- Possess weapon dangerous to public
- Unauthorized possession of ammunition
- Breach release order (x 5)
- Breach Probation (x1)

In addition to the new charges, Davis was arrested on three outstanding warrants.

After a judicial hearing Davis was remanded to custody and appeared in Breton Provincial Court on Jan. 26, 2022.

As these matters are now before the courts. no further details regarding the investigation can be released.

Committee of the Whole Meeting

January 25, 2022

Communities in Bloom (CIB) 2022 Budget Request

Thorsby Communities in Bloom Society (CIB) has been serving our community since 2005 and continues to work towards outdoor enhancement and great partnerships. New member Carol Rempel presented to the Council announcing the National CIB program wishes to have groups promote "The Year of the Garden" and has asked the Town of Thorsby to support this initiative. Joining this Year of the Garden 2022 is an opportunity for municipalities to demonstrate leadership and inspire and engage citizens. This also recognizes June 18, 2022 as Garden Day. They are encouraging residents & communities to incorporate red into their displays. The Council agreed to bring the proclamation to the next Council meeting for consideration.

Carol thanked Barry Rasch for building the presentation and budget and asked Council members to consider including \$4000 in the budget for this year's flowers. The CIB will also continue with the Adopt a Barrel program to recover the costs for the new planters that were purchased. The sponsoring business or individual will have the option to sponsor a planter of their choice and get a small sign in the chosen planter. Concern about the hanging planters was also addressed. The previous Council chose to have ground baskets instead of hanging baskets but some residents want them back. Public works has had some challenges with watering, hanging and storing in the past. Councillor Musson likes the idea of bringing back the baskets but hanging them on 52 Street where there is more traffic instead of downtown Thorsby. No decision was made, further discussion is needed. The budget request will be addressed at the next budget meeting.

Leduc County - Dean Ohnysty Director of Community Services

Mr. Ohnysty asked the Council to support a partnership between the Town of Thorsby, Village of Warburg and Leduc County. Leduc County has applied for a \$75,000 Alberta Community Partnership grant for the development of a recreation visioning document. This will set a long term vision for the communities. CAO Donna Tona expressed her support and importance of regional partnerships and providing vision. Leduc County will find out if the grant was successful in March. Dean assured the council that there is no funding commitment. Council supported this unanimously.

Introduction of the new Manager of Recreation and Culture - Kelley Probe

Kelley Probe, who was on her second day in her position, introduced herself to the Council. She has been in the community for over 20 years and was recreation manager in Thorsby for almost 6 years in the past bringing years of recreational expertise to the position.

Councillor Rasch asked about the Restriction Exemption Program for the Complex. Probe will look into the program to see if we can open more of the facility, and review the regulations around one-third capacity. Probe expressed that the staff has been doing a great job with all of the restrictions. Councillor Musson asked about the float and POS Machine. Probe indicated that setting up payments and POS at the Complex is a priority but until it is ready they will be taken at the Town Office. They are also working on getting the Computer program up and running to help with booking, memberships and more.

Interim CAO Donna Tona - REPORT

The month of January has been busy with troubleshooting, community engagement, residents' snow concerns and working with the staff. Reviewing the documents that are not in order or missing has also been a challenge.

Current FCSS coordinator Sandy Raymond will be done on February 1, 2022 and Tona expressed her gratitude for the great job that Sandy had done with Christmas Elves. Interim CAO Tona met with Calmar CAO regarding FCSS and they are considering working together. The new FCSS Office will be back at the Recreation Centre.

Staff are working on the Town's website. Document sorting is ongoing and they are continuing to sort through bylaws and policies but have to find signed bylaws before they are uploaded to the website. Tona also mentioned there is a huge cost to the upgrading of the Town's computers that had been purchased previously as they do not have sufficient software.

Tona met with the Staff Sargent at the RCMP detachment and met with the RCMP's Municipal Clerk. They paid Thorsby's portion of \$5,000 that was outstanding to share the clerk. Councillor Gilbert was concerned why we paid this \$5,000 and Tona explained it was in the policing agreement and required by all municipalities.

Rasch asked if there will be a public zoom at the next meeting and Tona said they are working toward having it ready.

Interim CFO Cindy Van Leest reported that they continue to meet with staff to work on the Budget.

Sometimes I need to shut down my computer for a bit, just to clear out the clutter from past tasks and make space for new input. The circuits become overloaded with information that has to be removed in order to receive new data. My mind is a lot like my computer at times, and sometimes it's almost as if The Beach Boys are talking to me about "Good Vibrations!"

I've found a simple exercise that helps me reboot my thinking process during hectic times like the holiday season, when I'm suffering from information overload:

Before starting, turn off your phone, television and computer. Tape a note to the doorbell that says, "Do not ring or knock." Sit in a comfortable chair and just relax for a minute or two. Close your eyes, take three deep breaths and let them out slowly. Now put the lid on tight! Un-tether the can and watch the balloon carry all that negativity away. Then take a deep breath, let it out completely and slowly repeat to yourself, "GONE."

Look **inside yourself** and you'll see lots of room that is ready to **fill full of good vibes!** The following **actions for a positive attitude** will help keep those vibes going.

- **1. Balance your life.** Though things in one area may begin to go bad despite your best efforts, concentrate on the positives elsewhere.
- **2. Keep going.** Don't give up. We all have setbacks. Don't think of them as an end but as a beginning.
- **3.** Make the most of it. If things are less than ideal, look for ways you can make them more pleasant.
- **4. Engage in positive self-talk**. Telling yourself you can do something will help you succeed.
- **5. Visualize success.** This will help make you more self-assured and comfortable in the situation when it occurs
- **6. Attack problems head-on**. When a negative situation occurs, find a way to turn it around.
- **7. Look on the bright side.** Make a habit to look at the good in life rather than the bad.
- **8. Maintain a sense of humor.** Don't take yourself too seriously. Look for the humor in dily annoyances.
- **9. Make work fun.** If you think your job is dull and boring, look for ways to make it interesting.
- **10. Accentuate the positive**. Concentrate on ways to use your strengths and abilities, and look for ways to improve your weaknesses

So there it is; Jesus gave them power over the devil and then He commanded them to go use it to set people free. First He demonstrated, then He equipped and sent them out. That is training!!

After Jesus was raised from the dead, having completed and finalized the defeat of the devil, He gave instructions to His disciples. "He said to them, "Go into all the world, and preach the gospel to every creature. He who believes and is baptized will be saved. But he who does not believe will be condemned. These signs will accompany those who believe: In My name they will cast out demons; they will speak with new tongues; they will take up serpents; if they drink any deadly thing, it will not hurt them; they will lay hands on the sick, and they will recover." After the Lord had spoken to them, He was received up into heaven and sat at the right hand of God. Then they went forth and preached everywhere, the Lord working with them and confirming the word through the accompanying signs. Amen" (Mark 16:15-20). That is dominion over Satan!! Here is another instruction that Jesus gave after He was raised from the dead. "Then Jesus came and spoke to them, saying, 'All authority has been given to Me in heaven and on earth. Go therefore and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, teaching them to observe all things I have commanded you. The steps we are taking now to listen to additional input will help ensure our elementary students are learning from the best curriculum possible." Adriana LaGrange, Minister of Education

The virtual sessions will be held from Jan. 31 to Feb. 28 across all five regions: north, Edmonton and surrounding area, central, Calgary and surrounding area, and south. Regional sessions will enable communities to share local insights and unique perspectives on the draft K-6 curriculum. Sessions will include focused, small group conversations facilitated by independent engagement specialists. During each session, the draft K-6 social studies design blueprint or one draft K-6 subject will be considered and discussed so Albertans can provide insightful feedback.

This spring, Alberta's government will carefully consider the feedback from all engagement opportunities and classroom piloting. This input will be used to finalize the social studies design blueprint, develop the corresponding draft social studies curriculum and further revise all subjects in the draft K-6 curriculum.

Quick facts

- At least 44 virtual conversation sessions will be offered across five regions at various times to meet Albertans' individual interests and schedules.
- Albertans are encouraged to participate in their own region, but they have the flexibility to attend any session that works best for them.
- Up to 120 Albertans can participate in each session.
- Albertans younger than 18 may participate with a parent.
- The French First Language and Literature session will be facilitated in French. Sessions for all other draft K-6 subjects and the draft social studies design blueprint will be in English. Live closed captioning and French facilitation will be provided for English sessions as needed.

NOTICE OF PUBLIC HEARING LEDUC TO ADOPT AN ALTERNATE **COUNTY ADVERTISING BYLAW**

Tuesday, Feb. 8 at 1:15 p.m.

Leduc County is proposing to adopt a bylaw establishing an alternate method for communicating information required under section 606 of the Municipal Government Act (MGA).

Under section 606 of the MGA, a council must give notice of certain bylaws, resolutions, meetings, public hearings or other things by advertising in a newspaper or other publication circulating in the area, mailing or delivering a notice to every residence in the affected area, or by another method provided for in a bylaw under section 606(1).

Section 606(1) stipulates that a council may, by bylaw, provide for one or more methods, which may include electronic means, to communicate proposed bylaws, resolutions, meetings, public hearings and other things referred to in section 606.

Leduc County is proposing the information be communicated electronically on the County's website, in addition to any other method deemed appropriate by administration.

A public hearing for the proposed bylaw will be held at the Leduc County regular council meeting on Tuesday, Feb. 8, 2022 at 1:15 p.m. Written or oral submissions can be made by any person who claims to be affected, or from any other person council agrees to hear from.

ALBERTA TO REACH EMISSIONS REDUCTION GOAL BY 2025

A new provincial report shows Alberta is on track to hit its methane emissions reduction target.

In the province's first progress report on methane emissions reductions from Alberta's oil and gas sector, data shows that methane emissions from these operations decreased by about 34 per cent between 2014 and 2020.

Based on these estimates, Alberta will meet its target to reduce methane emissions from the oil and gas sector by 45 per cent from 2014 levels by 2025.

Developing practical emissions-reducing technology to create jobs and diversify the economy is a key part of Alberta's Recovery Plan.

Funding for methane programs

Investing in technology, innovation and scientific research are central to Alberta's approach to reducing methane emissions. Alberta offers a number of programs that are helping the oil and gas sector improve methane emissions monitoring and management, including the Baseline and Reduction Opportunity Assessment Program. Due to high interest and uptake, Alberta's government is adding \$5 million from the Technology Innovation and Emissions Reduction (TIER) fund to this \$10-million program. This brings Alberta's total TIER fund commitment for oil and gas sector methane programs to \$57 million.

Milestone methane agreement

Alberta's equivalency agreement with the Government of Canada on methane emissions came into force in 2020. This agreement keeps Alberta in charge of regulating methane emissions. Without it, both provincial and federal regulations would apply in Alberta, increasing red tape and imposing additional costs onto Alberta's energy sector.

LETTER TO THE EDITOR

To the Editor,

I wish to spotlight the Thorsby Seniors Centre and all their hardworking volunteers for their work and success over the last number of years. This group of "present and passed" members and volunteers have worked hard to come from a group that met in the lower level of the Thorsby Community Centre and operated a small thrift store from a rented building on Hankin Street to owning there own facility. Volunteering and dedication is alive in Thorsby.

As a senior myself, I joined this Seniors group about ten years ago after moving to Thorsby from Spruce Grove. I learned they had an old building that was at one time an area school but had been demolished due to contamination. I further learned that they, through the hardworking efforts of their volunteers at their Thrift Shop and other fund raising efforts like raffles, breakfasts and bingos etc., were trying to earn enough money to build a new building on that same old school site as they still owned the lot. However these efforts were far short of enough to pay for the desired construction. So I volunteered to spearhead a multiple grant writing program to get the funds to construct a new and modern Seniors Centre.

Grants were written and presented to every level of government and some local large area companies. It took a year and we had accomplished our goal of scratching up enough money and then we quickly put together a volunteer Building Committee. I was subsequently nominated to Chair the Building Committee and start the building process. It involved resurveying the site, setting elevations, getting quotations and working internally with our Senior Centre Directors (of which I am one) to design what they wanted within the amount of money raised from all areas.

Once that decision was made we had to get an engineer to make up our drawings and blueprints for final quotes. Since we obtained grants from the Alberta Government, in fairness, we were obligated to list our building onto the Alberta website for all contractors and material suppliers in Alberta to be able to supply bids. I must say, I worked very hard to get most all materials and labor from Thorsby.

Construction took one year from getting our finances until the building was ready for occupation. During that year, we raised the money and added the appliances, television, new satellite, storage building for the Thrift Shop, moved in an old storage building, added a greenhouse, flagpole, parking lot lighting, and wonderful plants, shrubs and landscaping all through the efforts of our wonderful seniors and volunteers.

We are now proud to announce that through our member volunteer money raising efforts, personal donations and a generous C.E.F.P. grant of \$30,145.00 from the Alberta Government, in the spring we will have put together the total of \$65,000.00 to pave the Seniors Centre parking lot that will allow easier access to our building for seniors with walkers, wheelchairs and just cleaner trip-free building access.

The Thorsby Seniors Centre is debt free and self sufficient in paying all our own bills and continue to give back to the community by donating from the Thrift Shop to needy people of the area. we also provide, where possible, have activities, courses and fund raisers to name only a small number of things for our Seniors and residents alike.

We encourage any area senior 55 or older to join and grow with us. Our wonderful building is available for event rental and our Thrift Store is open for donations or sales on our posted times. I hope everyone sees this as a good news story as that is what we all need these days.
