

## WOMEN IN STEM SCHOLARSHIP OPENS FOR APPLICATIONS

Alberta's government will award a total of \$125,000 to young women pursuing careers in science, technology, engineering and mathematics (STEM).

This second intake for the Women in STEM scholarship, which was introduced earlier this year, demonstrates the Alberta government's commitment to supporting women in pursuing rewarding careers in these fields. Each successful applicant will receive \$2,500 to support their studies. The scholarship is open to women currently studying in STEM fields.

"During the first intake, Alberta's government was able to support 50 young women pursuing studies in STEM. We are committed to supporting women and girls to succeed in whatever career path they choose, including STEM. This commitment is even more important now, as emerging technology and innovation play a significant part of Alberta's economic recovery and diversification. - The scholarship received 106 eligible applications.
- The majority of applicants were attending MacEwan University, Mount Royal University, the University of Alberta and the University of Calgary.

#### **IDENTIFICATION REQUIREMENTS**

Local Authorities Election Act (Section 35)

Eligible voters must provide proof of identity and current residence to vote for councillor, school trustee(s) and Senate.

As per Leduc County's Voter Identification Bylaw (Bylaw 5-13), voters must produce the following for inspection by a deputy returning officer of the voting station:

**one piece** of valid government-issued identification containing the voter's photograph, current address and name

#### **OR**

- **two pieces** of identification from the following list:
  - Canadian military identification
  - birth certificate
  - ► Alberta Personal Health Card
  - baptismal certificate
  - Alberta identification card
  - ➤ Social Insurance Number card
  - certificate of Canadian citizenship
  - ► Royal Canadian Mounted Police identification card
  - Veteran's Affairs Canada identification card

- Old Age Security (OAS) card
- > student identification card
- credit/debit card
- library card
- hospital/medical card
- ► fishing, trapping or hunting licence
- marriage certificate
- firearms licence possession
- acquisition
- firearms possession only licence
- ▶ any other piece of identification acceptable to the deputy returning officer

If the deputy returning officer is not satisfied that the identification verifies the identity and age of the person seeking to vote, they make the final decision as to whether or not the person is allowed to vote.

Leduc County will conduct the Senate election and provincial referendum vote for the Summer Village of Golden Days. Eligible voters can vote at the following voting station from 10 a.m. to 8 p.m.:

Sandholm Community Hall (47376 Range Road 12)

#### **VOTER ELIGIBILITY**

Leduc County residents are eligible to vote if they:

- are 18 years old
- are a Canadian citizen
- are a resident of Leduc County on election day (Oct. 18)

Leduc County does not prepare a voter list. You must complete a declaration at the voting station that confirms you are eligible to vote. You can only vote in one jurisdiction, even if you have more than one residence.



#### **Town of Thorsby - Mayor Candidates**

#### What prompted you to run for mayor?

<u>DARRYL HOSTYN</u> - I am concerned about the state of affairs and after several people approached me to run for mayor I made up my mind to do so.

BARRY RASCH - I'm passionate and wish to make our community sustainable. Some are easy and others are complex to fix. By building a healthy team we can accomplish many things. We can't be dismissing concerns. I will go after community building initiatives as I did in the past. I will represent the rate payers with professionalism, integrity, and respectful debate. We need to give people a reason to move here that supports our tax base and businesses. We must solve problems rather than discredit the work of others. I will bring a positive, supportive approach to the chair.

**ROD RAYMOND (incumbent)** -The job this Council started is not done.

<u>CAROL REMPEL</u> - I am running for Mayor to encourage fair and transparent communication to listen to the concerns of the community, to value differences, and to create unity. My business background, facilitation skills, and chairing experience make me a perfect fit for Mayor.

**HOSTYN** - Address all resident concerns; prepare a plan for all streets and avenues that are unfinished; enhance bulk water sales and source out new customers; revitalize the use of Arctic Spas Recreation Complex; work to lower monthly water, sewage and garbage billing; and bring integrity to council and administration.

**RASCH** - Continued replacing infrastructure; look for efficiencies in operational and capital budgets; utilization of the water plant; main street revitalization; improve transparency and communication; create a more accessible community; and focus on economic development opportunities for our community.

**RAYMOND** - Deal with the water plant and finish the recreation center plan.

**REMPEL** - Be fiscally responsible, create partnerships, revisit a 5-year growth strategy, review bylaws and policies, upgrade aging infrastructure, encourage industrial park development, rejoin the 39/20 Alliance, unleash the potential of the Water Treatment Plant, and put the community first.

#### What is the greatest challenge facing Thorsby right now?

**HOSTYN** - Aging infrastructure (Water and sewer lines). Attracting new business to Thorsby.

**RASCH** - Operational and capital project expenses that continue to rise yearly.

RAYMOND - The financials and the future of the town.

**REMPEL** - The future of the Recreational Complex. It is imperative to work closely with Leduc County, advertising and marketing our facility to increase revenue. Many families, seniors and youth depend on the programs that it will offer. The Complex is one of our gems and the heart of Thorsby and used by many residents and visitors. It was built with grants and volunteers, and we must do whatever it takes to keep it running. Restoring respect, communication, and cooperation in all user groups and community members will be a start.

## How are you going to work with neighbouring municipalities to provide what the community needs at a reasonable cost?

<u>HOSTYN</u> - Regular communication to share ideas and cost saving initiatives.

**RASCH** - Work with communities of similar size to secure savings to our ratepayers - equipment sharing, capital project tendering, and sharing staff; respecting views even if they may differ; restore the 39/20 Alliance; and work on regional partnerships with others.

**RAYMOND** - We actively collaborate with the region. **REMPEL** - Working with neighbouring municipalities provides the community with services at a reasonable cost. The 39/20 Alliance gave us the opportunity to share our garbage disposal services at a much lower cost. Working closely with Leduc County also reduces

**REMPEL** - Following the Alberta Health Services protocol and supporting the businesses where possible. By shopping local we can help to keep the businesses alive. Encouraging outdoor activities will also help with depression and mental health of our community.

**HOSTYN** - Long-time third generation taxpayer and resident. Previous council experience. Previous Thorsby business owner.

Some of the paving completed this year was also a deviation from the plan, why?

Lastly, before you vote remember what we lost from this term 2017-2021. Do you really want that again? Very little road and pothole repair 2017-2020, loss of programming for families, loss of support for events for families, Experienced Staff, Thorsby Thunder Days, No Housing Development, No Business Development, Strained Relationships with Leduc County, Warburg, Calmar, Breton, Communication Breakdown and Transparency, No Regular Bylaw Support. I can go on, but you get the point. Total Doom and Gloom isn't what this community needs to constantly hear. ## TIPS From TOPS!

From P. Elson

A good walk or workout is one of the best ways to start or break up a brisk fall day. Taking the time to cool down with light stretches afterward may prevent aches and pains and possibly even stop an injury from happening. Plus, it feels good! Have fun and wind down with the "Pumpkin Cool Down" below. Just make sure that your muscles are nice and warm before you start.

Try holding each stretch for 7 to 10 seconds, repeating 3 to 4 times.

**P** is for **PRESSING** your palms up overhead with your fingers interlaced.

**U** is for **UPPER-BACK** stretch. With fingers interlaced, push your palms forward while dropping your chin toward your chest. Gently spread shoulder blades apart as you push palms forward.

**M** is for **MAKING** gentle arm circles. Make 10 forward circles followed by 10 backward circles.

**P** is for **PULLING** a resistance band apart with your arms out in front of you, palms to the ceiling at shoulder height.

**K** is for gently hugging your right **KNEE** while you're seated. Keep your left foot planted on the ground wile you perform a few hip circles, if it feels okay. Switch sides and repeat.

I is for taking a deep **INHALE** while you release your hands to your sides with your palms forward. Close your eyes and take a full deep breath in through your nose and an open mouth breath out.

**N** is for gentle **NECK** stretches. Sit up straight with your shoulders down and back and palms resting on your thighs. Slowly and gently bring your right ear towards your right shoulder, feeling a stretch along the left side of your neck. Switch sides and repeat.

#### **Town of Thorsby - Councillor Candidates**

#### What prompted you to run for town council?

**IVOR FOSTER (incumbent)** - It has been my pleasure and honor to represent Thorsby taxpayers. The Mayor, Councilors, and CAO have solved a number of problems facing the Town and I want an opportunity to finish the work we started.

<u>CORY GILBERT (incumbent)</u> - A desire to continue working on some of the solutions that we have started on this past term in council.

JILLIAN HALLIDAY - I am tired of sitting on the sidelines and not being heard. I have a passion our community. The ideas and concerns of residents matter and I have a drive that can assist the changes needed for a positive future.

JASON KINSWATER - It is time to bring some new ideas to old problems of Thorsby. Being disappointed with the lack of progress in infrastructure repairs and business development, I can use my education to implement a basic economic plan with a focus on population density.

JOHNATHAN MILLER - I wanted to run for Council because working out of town made me miss a lot of my children growing up. I want to be more involved in shaping their future and giving them a great community to grow up in.

**TRACY MUSSON** - Others believe I am a good fit for the role and, having attended Council meetings, I am familiar with the work. I am concerned that the lines of communication are not efficient. We need our town to thrive.

**KENNETH POFFENROTH (incumbent)** - Four years ago I was unhappy with my taxes going up because of what I believe was mis management and inexperienced persons making costly decisions. Our town debt was run up in great jumps being past on to us taxpayers. I wanted some say in reducing or eliminating these costly decisions. Secondly the town water system.

FRANCESCO (Frank) RAFFA - Thorsby needs something better compared to the current state as there is so much potential in this community. The bullying and negativity need to stop in order to foster a successful and thriving town. We can do this through teamwork.

SHELLEY RASCH - A lack of communication from Council and Administration; huge turnover of staff; the disrespectful way residents and businesses are treated by the CAO and Council; the lack of FCSS, and

the poor management of the rec centre.

NATHANIEL (Nathan) RAYMOND (incumbent) - The pandemic forced us to delay many projects, especially in recreation and activities. Infrastructure projects were also delayed along with intermunicipal collaboration agreements.

<u>AUDREY WATSON</u> - Having worked for the town for many years, I've heard a lot of negativity about how and what is going on. I felt that maybe I could help to make changes for the better.

**BARBARA WORSHEK** - It's time for change. Council needs to listen to the concerns of the people and businesses with respect and consideration, not with threats of legal action.

#### What are your goals should you be elected?

**FOSTER** - Infrastructure remediation with the help of the financially-minded CAO; reviving May Long Weekend activities when it is safe to do so; reinvigorating a Thorsby Community Advisory Board to build community; maximize the potential of the rec centre; attract developers; and address the water treatment plant.

<u>GILBERT</u> - Taxes need to be further reduced in a sustainable manner; eliminate franchise fees: (hidden municipal tax that is added to your power and gas bill); continue to work on infrastructure projects; and ensure that Thorsby has good policies that are consistently and fairly practiced.

<u>HALLIDAY</u> - Reopening and revamping the programs at the recreation center; build a community my kids want to return to after their post-secondary education; upgrade buildings; and foster better lines of communication with residents.

KINSWATER - Bring respect and integrity back to Council; build a relationship of trust with the community; create lines of communication to the community; evaluate and reduce bylaws to reflect need; establish a cost-effective infrastructure plan; reinvigorate youth programming at the Complex; and implement small business strategies to reduce water costs.

MILLER - Find out what youth programs the Council was working on and see what can be improved and actioned; solve the Taylor Park issue; pave all unpaved roads; and better leverage the potential of the water treatment facility to benefit Thorsby.

<u>MUSSON</u> - Repairing relationships between CAO, Council, residents, and businesses - right now citizens feeling unheard or ignored. The Rec Complex needs to start pumping again - activities bring people together, which is a joy of small town life!

**POFFENROTH** - Apply sound management experience and decision making. Continue to reduce taxes and town debt as we have for the last four years while delivering affordable service. That is why taxes were reduced some 20% in the last two years.

RAFFA - Better reputation and relationship with the

community; work with neighbouring communities; more community events; more youth activities; better facility usage; build a balanced tax plan; address infrastructure issues; foster growth and development; locally source staff and tenders; and foster students' academic endeavours.

**RASCH** - Reestablish relationships with businesses, community groups, and surrounding communities through communication; be respectful, transparent, and honest; get the recreation centre and programming back on track; work with CAO to reevaluate staffing; address the water plan; evaluate infrastructure priorities in the coming years; and business development.

**RAYMOND** - Work with Council to achieve the best outcomes for our Town; always be available to our residents; and supporting youth in town as I pledged to make them feel as important as the rest of our residents.

<u>WATSON</u> - Having everyone feel that their voices will be heard.

**WORSHEK** - Address the school's concerns on our children's safety, our safety, and the safety of the community at large; address the debt; focus on infrastructure; have something viable in place for youth recreation; understand what has happened to our Complex; and conduct a viability report.

#### What is the greatest challenge facing Thorsby right now?

<u>FOSTER</u> - Negotiating a reasonable contract with the union is quite challenging. The reality of the unrealized potential of the water treatment plan and aging infrastructure. Maximizing the potential usage of our Recreation Centre.

<u>GILBERT</u> - Water. We have spent a great deal of time seeking out options to address this issue and a number of possible solutions are available. But it is a complicated problem with complicated solutions so it is important to get it right rather than do it fast.

**HALLIDAY** - The greatest challenge I believe we have, is our infrastructure. We need to take a hard look at the condition of some of the roads, the water infrastructure, and costs.

**KINSWATER** - Building a new relationship with the people of this community. Visitors to the Town Office should feel that our town is being honest, respectful, and answering questions or concerns in a timely manner. It will be a major challenge to repair this broken relationship.

MILLER - In my opinion, the waste and misuses of our town's budget and resources. The miscommunication or lack of communication. There is more of a blame game than a transparent problem solving mentality.

**MUSSON** - High taxes and water fees. Filling our empty lots with homes and attracting sustainable businesses, could lead to more affordable taxes. The businesses and people we have in Thorsby are great,

there is plenty of room for more!

**POFFENROTH** - Our unaffordable water system with crumbling infrastructure below ground. Over many years the underground system was not maintained and here we are trying to slowly rectify the neglect. Secondly would be electing unproven management to council.

<u>RAFFA</u> - The division between management, Council and the people. The cost of living should be the biggest challenge, but this lack of unity is a pressing issue. Working as a team, we can create a better, more affordable Thorsby.

**RASCH** - The rising costs of repairing and building new infrastructure, roads, and sidewalks; and encouraging businesses and new builds to Thorsby.

**RAYMOND** - The greatest challenge facing Thorsby right now is our failing underground infrastructure, and our liability of the water system, if there were to be a failure the cost would be astronomical.

<u>WATSON</u> - Encouraging businesses to come to our town; making water rates that are more affordable; better usage of our recreation facilities; and more accountability for money spent.

**WORSHEK** - Dealing with debt and infrastructure.

How are you going to work with neighbouring municipalities to provide what the community needs at a reasonable cost?

**FOSTER** - The 39/20 Alliance cost \$5000/year for little benefit so Council sought out its own agreements with neighbouring communities to realize greater savings. The provincial government may require municipal resource sharing and our prior work puts us ahead of the curve.

<u>GILBERT</u> - The best intermunicipal agreements we have that result in a net benefit to Thorsby have come through open communication and a willingness to cooperate, which does not cost the taxpayer anything.

<u>HALLIDAY</u> - As I do feel Thorsby is the best, I believe that with a close working relationship with surrounding communities, we can, and will, only get better.

KINSWATER - More cost-sharing opportunities need to occur. There may be ways for all of our communities to share public works equipment during maintenance or breakdowns. Group costs could be reduced by bidding together on garbage and recycling programs. Friendly recreational competitions with other communities could be fun.

MILLER - Well, I would have to get voted in first, but discussing with the new Council, reviewing the areas we could improve on, and how we could come to a plan that will work for everyone.

<u>MUSSON</u> - I believe that as a small town we need to work jointly in agreements with neighboring communities to which would benefit all. eg. The same garbage contractor may give premium rates if utilized in close proximity.

**POFFENROTH** - We have, over the last couple of years, put together a large working relationship with all the large municipalities south and west of Edmonton. We now have agreements on emergency services, sharing of information on major issues and agreements allowing purchase of equipment before it goes up for public sale.

**RAFFA** - Working with neighbouring municipalities adds to our collective ability to host events, gain buying power, and apply for grants, etc. Starting with a needs assessment, we can keep costs reasonable by working together and increase community spirit.

**RASCH** - Reestablish the broken relationship with the 39/20 Alliance and encourage joint communication with neighbouring communities, look at cost sharing, and the sharing of ideas/plans.

**RAYMOND** - We have during this term signed multiple intermunicipal agreements (including emergency management, development) and intermunicipal collaboration frameworks that give us the opportunity to share services and attain affordable capital assets. Continuity of this process and our ability to have good working relationships is ongoing.

WATSON - I feel that this is a mayoral question but that

I would be very happy to work with the municipalities and surrounding communities in sharing our resources - be it recreation facilities, park spaces, or infrastructure assets to help reduce costs for everyone.

**WORSHEK** - Become again a partner of the 39/20 Alliance for businesses and for the sharing of assets and equipment to benefit all the communities involved. Engagement of trust and sharing makes all our communities stronger, safer and more fiscally responsible.

How can Thorsby best navigate the ongoing pandemic in a way that supports development while keeping people safe?

**FOSTER** - We followed AHS rules by closing out our recreation centre. It was reassuring to see the townspeople following reintroduced guidelines this fall. If I am reelected, I would definitely be in favour of a cautious reopening approach.

GILBERT - Continue a gradual reintroduction of service which can be managed, monitored, and adjusted up or down modestly to adapt to changes. The Town needs to provide consistency and predictability. The slow and measured approach can provide a stronger base to build back up from and avoid making knee-jerk reactions and unforeseen consequences.

**HALLIDAY** - For us to best navigate the ongoing pandemic we need to make sure that we are adhering to the safety guidelines that we are provided with.

**KINSWATER** - The number one priority of any council should be to maintain the safety of all its citizens by following the most current Alberta Health guidelines to the best of their ability. It's up to the Council to give its community and local business more support.

MILLER - Everyone wants to be safe but they also want to live their lives and do what's best for their families. AHS sets most policies. Cover when coughing or sneezing, wash your hands frequently, respect others boundaries, and if you're sick or showing symptoms stay home.

<u>MUSSON</u> - Ultimately, following AHS rules, of course. There is no reason that we can't offer programming, new businesses, new construction of homes, etc. If this is our new normal, carry on, continue living!

**POFFENROTH** - COVID is now a world problem with no end in sight. We must follow Alberta guidelines so there is no choice there. We also have a union contract to work with on starting-stopping services. This means layoffs and restarts can be costly and slower than other municipalities.

**RAFFA** - Addressing the fears that the big media has been pushing on people as a whole. There are communities that are operating without segregating people and allowing people to determine their own safety measures according to their personal conditions.

**RASCH** - We continue to keep open for business and programming while following AHS guidelines.

**RAYMOND** - We have to continue supporting provincial mandates and provide direction within the community on how best to deal with the situation, as it has changed so many times, it may change again in a blink of an eye.

**WATSON** - If we follow the AHS guidelines there should be no problems with welcoming businesses and everyone to our town. Our recreation centre stayed open during the last complete shut down until the last possible moment. With proper procedures for cleaning in place and protocols followed there should be no problems in reopening.

**WORSHEK** - Each individual has their own right to decisions they make for themselves. We need to join together for the good of all. Businesses need respect from their community so they can serve us during this, and all, times. Development will come if we support each other.

#### What else would you like voters to know about you and your bid to be a Town Councillor?

**FOSTER** - I am thankful for the trust that citizens placed in our council and we can be reelected to finish the work. I am a good listener and have always believed in the goodness and fairness of my fellow man.

**GILBERT** - Aside from my background in business and the trades, I also have a post-secondary education in political science which I find is very helpful in being effective on Council.

**HALLIDAY** - I feel the love, hear the concerns, and want to be part of growth. I am able to listen with an open mind and use my voice when needed. I would consider myself a town resident before being a councillor.

KINSWATER - I grew up just outside Town and my wife, Katie, and I moved back 16 years ago to start our family, which reengaged me in the community. I was involved in a workplace accident and am working on my Business Administration-Entrepreneur designation.

MILLER - I believe Council needs to be transparent with the community, ensuring residents are both informed and included. The Town Office should be able to help residents find the information they need and everyone should be treated fairly.

<u>MUSSON</u> - To anybody that does not know me, I can assure you that I will be trustworthy, accountable, responsible, ethical and make decisions which will impact others with a clear conscience.

<u>POFFENROTH</u> - I want our voters to know my experience and success is top notch. I have 50 years of manufacturing management experience. I have spent years on various boards like PSAC Argus Machine, and Stoneham Drilling (a TSX corporation). Can other candidates match it?

<u>WATSON</u> - Worked for the Stollery pediatric OR for 26 years and have worked at the Thorsby recreation centre for 10. I was raised in the Glen Park area and remember Thorsby's history. Hopefully, we can work together to make Thorsby great again.

**WORSHEK** - I think of running for Council as a volunteer position - many hard hours for the benefit of a community I love. It is a huge commitment and I have experience helping out with many organizations after 34 year in this community.

**WORSHEK** - Spuds and eggs.



I don't think I have to introduce myself, but I was part of the most dynamic council the Town of Thorsby has had in a long time.

I have spent most of my life in service to others as a teacher, ski patroller, ski instructor, volunteer ski host in Marmot Basin, and passenger service agent with Wardair Canada. Following is a list of projects that are proposed or in progress.

- The water plant, a financial drain, already in discussion, must be addressed next council.
- Efforts have been made and will continue to get legitimate developers and intransigent landowners together to attract more people to live in Thorsby. Remember: more citizens, more tax revenue, more reason to attract business to Hankin Street. A win-win!
- Re-start the pre-Pandemic discussions meant to form a working group of citizens to undertake projects that will be an asset to our community.
- Our new and personable Recreation Manager has already formulated a management plan and will welcome community input.
- The Mayor/CAO monthly working meetings with other Leduc County municipalities has already borne financial fruit in cost savings for Thorsby and will continue in the future at no cost to the community.
- We will continue posting budgets and quarterly financial snapshots on our website.
- We will continue to work on the issue of transparency. Our council meetings have always been open to the public and we encourage public interaction and visitor engagement during meetings.
- More emphasis is being taken on enhancing communication. Installation of the electronic sign beside the Chamber of Commerce sign has officially been approved by the Alberta Transportation and construction will be started before freeze-up.
- We are presently waiting for approval of our \$900,000.00 accessibility grants for the Recreation Centre.
- We will continue to fine-tune our by-laws and policies where necessary.

### Accountability and transparency according to Rod Raymond

No one toots their horn about transparency more than Mayor Rod Raymond. Under his watch, the Town is being run the way it should be—the Rod way. Everything runs fine as long as you don't argue, don't ask questions, and don't look too closely at how the town is mismanaged.

Most municipalities require quotes and do not sole-source contracts. Not in Thorsby. Take GWI, or Gilbert Williams Industry, a local heating and plumbing company. If the company's name sounds familiar, it's because Councillor Cory Gilbert is one of its owners. Under Mayor Rod, it seems business naturally flows to GWI. Now I get it, we should all support local businesses, but I have a problem when some businesses get special treatment. And, I seriously question whether we, the taxpayers, are getting value for the money being spent to maintain and operate Arctic Spa Recreation Centre.

After four years in office, it appears Mayor Raymond is unfamiliar with the Municipal Government Act. It states: Although there is no prohibition on doing business with the municipality when you are a member of council, every contract or agreement with the municipality in which you have an interest must be approved by council (section 173 of the MGA). Allow me to explain this to you, Rod. Under the MGA, Council needs to approve any contract involving a Councillor's business. You cannot make up your own rules. If you really believed about accountability and transparency (rather than just talking about it on Facebook), you would publicly disclose which member(s) of Council have a business relationship with the Town and how much money they have received to date.

It appears there is an uneven playing field when it comes to issuing work in Thorsby. Some companies do not have to provide estimates and compete for tendering of contracts, small and large. This creates major accountability issues. For example, if there is any deficiency in the work done by a Councillor's company, it is highly unlikely that the Town Manager, who reports to the Council, will risk a confrontation with the Councillor. I get nervous when companies owned by elected officials get business with no quotes, no agreements, and no contracts. They simply get paid.

Ask yourself, should the Mayor follow the rules in the *Municipal Government Act* or be allowed to make his own? Should a Councillor's company receive preferential treatment for work in the town? And, when a Councillor has a pecuniary (financial) interest involving the Town, should it be publicly declared?

The Rod way is to look the other way. Remember that on October 18th.




