90-YEAR-OLD LANDMARK DESTROYED BY FIRE

The Breton Museum was saddened to learn the lost of one of the last remaining log structures in the Breton community. During the night of December, 30th the New Moose Hill Community Centre was destroyed by fire. Although the building hadn't been used as a community centre for the past several years, it stood as a tribute to the early pioneers who settled the New Moose Hill area in the late 1920's.

About 1928, a number of families homesteaded land west of Breton. Within a short period of time the need for a school was required for their children. This was long before the days of good roads, and bussing to larger centres was feasible. Along with some assistance from the provincial government, each small community was responsible to provide a school for the education of their children. Meetings were held to organize a school district, and on November 27, 1929 New Moose Hill School division # 4453 was established. The school district was named for the large hill on which the school was built called Moose Hill. It was no easy task to operate a school during this time period. The Depression of the 1930's had descended on the community. The school board was responsible for the collection of school taxes and the operations of the school.

Logs were cut for the construction of a log

school house located of the SW 13-48-5-W5, and in the spring of 1931 construction began, with many local families helping. Under the expert axeman ship of Simon Sorgaard, the logs were fitted using dovetail corners.

By March of 1932 the school was ready to open. The first teacher hired was Miss Mary Hunka, from Ryley, Alberta. Miss Hunka had just completed her teachers training. and at age 19 this was her first school. Her first class consisted of 10 pupils, seven girls and three boys. It was not an easy task for Miss Hunka, as

some of the students hadn't been to school for some time. With her dedication to the teaching profession, she was able to send extra time to help the students catch up on their courses. Miss Hunka would teach four years at New Moose Hill before Miss Woods came to teach at the school.

The New Moose Hill school would operate as a school from 1932 to 1949. By 1949, centralization of one room schools was starting to take place. New Moose Hill School was no different than many other schools. That year Roy Prentice was tendered to provide bus service to Breton for the students from the New Moose Hill School. The almost non existence of roads required that a four-wheel drive jeep vehicle was required, and even then, he required a team of horses to get him through his route at times.

After the school closed the building stood unused until the mid 1970's when a school reunion was held at the school. Soon after the community gave the old school a second life by establishing a Community Club. Soon the sound of dance music could be heard from the building as it had done in previous times. An addition was made to the original school, ball diamonds were added, and for a number of years slow pitch ball games and tournaments, along with community functions kept the building relevant. However, time marched on and eventually the building stood quiet again this time forever.

Thanks to Betty Williams' donation, the Breton Museum is fortunate to have within its archival collection some of the record books and school registers to retain memories from New Moose Hill School.



MLA REPORT

from The Office of MLA Mark Smith, Member of the Legislative Assembly for Drayton Valley - Devon

For Albertans living outside the two big cities of Edmonton and Calgary, the announcement of a memorandum of understanding (MOU) for broadband funding between the Government of Alberta and the Government of Canada was an early Christmas present.

Having reliable, high-speed internet connectivity is important for all Albertans, and it is essential to Alberta's recovery and for economic diversification. That's why it's so great that Service Alberta Minister Nate Glubish secured a dollar-for-dollar matching funding agreement between the Government of Alberta and the Government of Canada.

From education to agriculture to small business, reliable connectivity will help Albertans interact with the global economy, innovate for local solutions, and succeed. The COVID-19 pandemic has highlighted more than anything else could, the need for better connectivity in rural, remote and Indigenous Alberta communities.

Since Alberta's government announced up to \$150 million in broadband funding this past July, many people have asked how the money would be deployed and what the province's timeline for universal connectivity is. While the MOU was signed in August between Minister Glubish and his former federal counterpart, Maryam Monsef, a federal election was called and a new cabinet sworn in, which meant that those details could not be released until now.

Now that we can talk about how the \$300 million in joint funding will be deployed, it's important to reiterate something Minister Glubish has consistently said over the past two years: we cannot afford to duplicate work and overbuild. With a need to reach the 80 per cent of First Nations communities and the 67 per cent of rural and remote communities that do not currently

have reliable internet access, we need to be strategic and work together with all levels of government and the private sector to fund shovel-ready projects that have the greatest impact. The best way to do this is to leverage the applications that were already submitted to the Universal Broadband Fund (UBF). In doing this instead of creating a separate provincial grant program, all parties working to eliminate the digital divide are working together and not in competition.

Leveraging the UBF program also means that both governments have been able to spend the past several months reviewing the hundreds of applications received from Alberta project proponents so that the first projects can be announced in early 2022 and shovels can be in the ground during the 2022 construction season. Broadband connectivity is a priority for Alberta's government, and we are pushing to connect Albertans as soon as 2023/24. That is an aggressive date, but it is important that we signal to all Albertans and all our partners in the private sector and in other levels of government that we are committed to ending the rural-urban connectivity divide.

We also must be realistic, and it is far more likely to take an additional several years to achieve universal connectivity. Part of the reason for this is that there is only so much industry capacity to complete the work and, because of the pandemic, supply chain issues are affecting the global availability of materials – for fibre optic cable, electronics, and other items because of the pandemic.

This collaboration is a game changer for rural Alberta and we're working hard to get projects announced and shovels in the ground.



Physical Healing

I have heard it said that Jesus died for our spiritual healing. This statement is not at all true. Jesus died so that we could have forgiveness of sins and be made righteous, the same as He is righteous. In the process we also receive a new spirit and physical healing. This is plain to see in the Bible if we are willing to read it as written. Let's start with 1 Peter 2:24. "He Himself bore our sins in His own body on the tree, that we, being dead to sins, should live unto righteousness. 'By His wounds you were healed'" (Modern English Version 1 Peter 2:24). Notice especially the last part of that verse, "By His wounds you were healed". The wounds Peter is referring to are the wounds that Jesus received when He was whipped before He was crucified (Matt. 27:26). He took those wounds for our physical healing. Peter is actually quoting a prophesy about Jesus from the Old Testament "Surely he has borne our grief and carried our sorrows; Yet we esteemed him book of Isaiah. stricken, smitten of God, and afflicted. But he was wounded for our transgressions, he was bruised for our iniquities; the chastisement of our peace was upon him, and by his stripes we are healed" (Isaiah 53:4-5). The Hebrew word used for grief in this passage includes sickness, disease, and calamity, as well as grief. The Hebrew word that sorrow is translated from means physical pain, mental pain, affliction, and sorrow. Healed is translated from a Hebrew word that means to cure, to heal, make healthful and make whole. When we accept these scriptures as written we can clearly see that they are talking about physical healing.

I have one last nail to drive into the spiritual healing coffin, and that is Matthew 8:14-17. "When Jesus entered Peter's house, He saw his wife's mother, lying sick with a fever. He touched her hand, and the fever left her. And she rose and served them. When the evening came, they brought to Him many who were possessed with demons. And He cast out the spirits with His word, and healed all who were sick, to fulfill what was spoken by Isaiah the prophet, 'He Himself took our infirmities and bore our sicknesses'" (Matt. 8:14-17). This short passage removes any doubt as to the context of 1 Peter 2:24 and Isaiah 53:4-5. The Word of God means what it says. Jesus cast out demons and physically healed all who were sick to fulfill the prophesy in Isaiah 53:4-5. That is the same physical healing Peter referred to when he wrote "By His wounds you were healed". Also notice that he said were. That word is past tense. Peter wrote this letter after Jesus had been whipped for our healing. We were healed when Jesus was whipped; our healing has already been provided. All we have to do is believe Jesus and take a stand against the devil who stole our healing from us.

Concerns About Brazeau County Road Requests and Code of Ethics

I attended the Brazeau County Regular meeting on Dec 7, 2021. During the public input session, I spoke about the budget and roads which were requested by councillors. I commented that the road requests were not on the 5 or 10 year plans. I then asked if these roads were only for political reasons. The Reeve, (Bart Guyon) interrupted me and in an outburst, said "That's a lie!"

My concern is:

There is a certain criterion which need to be met before roads are built, up graded, or paved.

This criterion then justifies the use of County funds for this purpose.

I have noticed that several of the road projects do not meet this criterion and therefore they are not justified. There are roads on the 5 and 10 year plans that seem more needed and have been left on the "back burner". This makes me wonder if the ones being done are built for necessity of the greater good and population, or whether they are built only for political reasons.

I also attended the Brazeau Council meeting on Tuesday, Dec 21,2021. During the first part of the meeting, the Reeve, (Bart Guyon) spoke to me. He stated he had lost control and was apologizing. I did not speak at this time, as this was not during a public input session. Later, during the public input session, I stated I was not accepting the apology. I felt during the December 7th meeting, I should not have been interrupted by the Reeve nor insulted by him. I then stated, "It is up to Council to deal with this according to the Council Code of Ethics."

My feeling is people on Council should be able to control their emotions and listen to all enquiries. These enquires should then meet with answers from the Council. All people should be treated with respect.

To the Editor:

Sometimes there's more to a situation than meets the eye (at first). Take for example the Code of Conduct currently being considered for renewal by our Council.

Back in 2014, the Code then in force used words and expressions like the following: "... to the advantage of the municipality." "... the common good of the county as a whole ..." "... to serve the best interests of all the people ..." "... the best interest of the County ..." (used twice) "... Earn the respect and confidence of the public ..." "... A Councillor has the responsibility to keep informed on all local ... government developments..."

The current code has only two statements that come close to the above.

It should be noted that Councillor Westerlund made a statement to the effect that the Code is a "Council" document (this writer was in attendance). Need she be reminded that **all** documents are for the **public** benefit. Are Councillors not paid to look after ratepayer (not Council) interests?

It should also be noted that in the first Section of the current Code it is stated that "...the public is entitled ...to the highest standards of conduct ..." and in (3a) Councillors "... not engage in actions which are damaging to the trust, ... confidence and faith of the public." Section 6a states Councillors "... shall treat every person ... with dignity ... and respect."

In this regard, at an early Ag Service Board meeting (recorded on tape), several members of the Board were understood to "demean" a member of the public (who was in attendance) after that member left the meeting. At a budget meeting the next day, one Councillor "attacked "another Councillor (verbally) about his contribution to the ASB meeting. These actions are unacceptable according to common courtesy and the "Code of Conduct." (note previous paragraph)

It remains to be seen how council will handle (or not) these transgressions.

As a starting point, offending members should be dismissed from the ASB and the Council meeting offender be removed from Council for six months (for example).

Perhaps the offending members should return their \$1500 stipend since the Code has not been studied. Why is it that the public has a better handle on the Code than those that are paid to know it?

Run these ideas past your Councillors and evaluate their response.

What is a vape?

A vape is an electronic smoking device that contains a cartridge of liquid (e-juice) that may containe nicotine or cannabis (THC) in a liquid form. The e-juice is heated into an aerosol cloud and inhaled by the user.

What should parents look for?

Parents should pay attention to an unusual attachment to a USB stick, sharpie, pen, lipstick, key fob, etc. These items may be a vape "disguised" as everyday items.

Vaping is not harmless

Vaping can increase your exposure to harmful chemicals and lead to nicotine addiction. The short and long term health effects are unknown. Recent reports show an increase in vaping-related injuries; including significant respiratory and health effects such as lung failure, seizures and even death.

Although rare, some vaping devices may catch fire or explode, leading to burns or injuries.

What is in e-cigarette liquid?

Nicotine, which is a highly addictive drug.

A combination of water, chemicals and propylene glycol, which is a food preservative and is in antifreeze and theatre fog.

When the chemicals in e-juice are heated, they form new toxic compounds including formaldehyde and acetaldehyde, known to cause cancer; and acrolein which can severly irritate the eyes and airways. Added chemicals for flavour may not be safe to inhale and they can irritate the lungs and airways.

Talk to your teen about vaping

Talk to your teen about vaping early, even as young as age 10.

Know the facts so you can disucs the health risks and nicotine addiction.

Focus on the short-term effects of vaping – it can change the way your brain works, may make it harder to breathe, it costs a lot of money, and youth are the target of big companies looking for lifelong customers.


