Houskeeping subsidy

Provides access to affordable housekeeping services through a partnership with Serving Hands Senior Care Inc. To be eligible for the housekeeping subsidy, you must:



CANADA EMERGENCY BUSINESS ACCOUNT LOAN FORGIVENESS REPAYMENT **DEADLINE EXTENDED**

OTTAWA: Gerald Soroka Member of Parliament for Yellowhead wishes to advise that the - Canada Emergency Business Account (CEBA) Loan Forgiveness Repayment Deadline has been extended. The repayment deadline for CEBA loans to qualify for partial loan forgiveness is being extended from December 31, 2022, to December 31, 2023, for all eligible borrowers in good standing.

This extension will support short-term economic recovery and offer greater repayment flexibility to small businesses and not-for-profit organizations, many of which are facing continued challenges due to the pandemic. Repayment on or before the new deadline of December 31, 2023, will result in loan forgiveness of up to a third of the value of the loans (meaning up to \$20,000).

Outstanding loans would subsequently convert to two-year term loans with interest of 5 per cent per annum commencing on January 1, 2024, with the loans fully due by December 31, 2025.

The repayment deadline to qualify for partial forgiveness for CEBA-equivalent lending through the Regional Relief and Recovery Fund is also extended to December 31, 2023.

Village of Warburg Council Meeting NOTES January 10, 2022

Request for Joint Council meeting with Leduc County

Mayor and Council asked CAO (Chief Administrative Officer) Chris Pankewitz to send a letter to Leduc County requesting a joint meeting. Mayor Mayr said he would like to change the perception of the west end of the Municipality. This Council wants to encourage information sharing and partnerships whether they can meet annually, semi-annually or quarterly.

Leduc & District Food Bank Funding Request

The request for funding support was approved in the amount of \$1000 which is the same as last year's funding. CAO Pankewitz also mentioned that there were less hampers than anticipated and therefore there are some items that will be donated to the Leduc & District food bank which supports the Warburg Community year round.

Crime Watch

Crime is prevalent in our local community and surrounding areas. This causes concern on many levels and hurts local business. It was mentioned that a registered COP (Citizens on Patrol) Association can be registered as a non-profit and will have bylaws or terms of reference. A registered group would get an RCMP liaison. An informal group could not be registered and therefore would not have insurance. Councilor Hart indicates there can be some liability when individuals take matters into their own hands (regarding crime/criminals) a public meeting would help educate the community. Mayor Mayr also mentioned that the time commitment must be considered so it is not too much for volunteers. Councillor Laing wondered if this could be an opportunity for the 30/20 Alliance to work together. Councillor Henderson spoke about how the RCMP knows suspects and continues to bring them in but the Justice system is another challenge. The Mayor and Council advised CAO Pankewitz to set up a local town hall meeting to garner interest and get some information to the community on this opportunity.

MLA Mark Smith - Delegate

The issue of crime was still on the table when MLA Smith joined the meeting. He agreed there can be problems at the judicial level. MLA Smith is in full support of a local crime watch.

MLA Smith congratulated the Mayor and Council on the election. Right now the budget is the primary concern and under review. He also said that statistics say the economy is turning around, they haven't had such a low unemployment rate since before the COVID-19 pandemic.

The difficult decision to push school re-entry at the beginning of January was mostly due to lack of employees. The province is currently working through curriculum rewrite.

The discussion of provincial policing versus the RCMP was briefly discussed. There is a fear for change but local control and individuals staying in the community longer may be a benefit. MLA Smith says there seems to be about a 50/50 split on whether people want to continue with the Federal RCMP or switch to a Provincial Police Force. More meetings are coming up to inform and discuss.

The announcement in December of the \$300 million combined contribution between the provincial and federal governments to improve high speed internet in rural, remote & indigenous communities was briefly discussed. Mayor Mayr asked how to access this funding and was told they just have to wait a bit longer to find out how to apply.

Warburg Mayor and Council told our MLA how the NP (Nurse Practitioner) Pilot program in Warburg/Thorsby was a great success. CAO Pankewitz also mentioned

that Warburg is still waiting for the funds for the Water & Wastewater grants that were applied for. She also mentioned that Warburg is losing approximately 60% in (MSI) Municipal Sustainability Initiative funding.

MLA Smith will continue to address issues and questions on behalf of our rural communities.

Application to Amend Land Use Bylaw

The Warburg Cultural Society has asked to rezone the Cultural Centre to "Public Use District". The Village's Assessor has recommended waiting until the temporary Commercial business has moved out. After discussion it was decided that as long as there is no urgency for grant applications or other reasons, they will put this on hold. The application was submitted before the ATB/Direct Line Insurance building was destroyed and needed temporary space.

Warburg School

Concerns were put forward from Councillors Henderson and Laing regarding the lack of facility use and extracurricular activities. CAO Pankewitz said they have a joint use agreement with the school and ice is free during school hours. It was agreed that further discussion was needed and asked CAO Pankewitz to extend an invitation to Black Gold Trustees, Superintendent and Principal Maltais to discuss partnerships and options for this underutilized facility.









Leduc County is proposing to adopt a bylaw establishing an alternate method for communicating information required under section 606 of the Municipal Government Act (MGA).

Under section 606 of the MGA, a council must give notice of certain bylaws, resolutions, meetings, public hearings or other things by advertising in a newspaper or other publication circulating in the area, mailing or delivering a notice to every residence in the affected area, or by another method provided for in a bylaw under section 606(1).

Section 606(1) stipulates that a council may, by bylaw, provide for one or more methods, which may include electronic means, to communicate proposed bylaws, resolutions, meetings, public hearings and other things referred to in section 606.

Leduc County is proposing the information be communicated electronically on the County's website. in addition to any other method deemed appropriate by administration.

A public hearing for the proposed bylaw will be held at the Leduc County regular council meeting on Tuesday, Feb. 8, 2022 at 1:15 p.m. Written or oral submissions can be made by any person who claims to be affected, or from any other person council agrees to hear from.

The Bible Truth Page

Are you his Disciple?

If we have made Jesus our Lord, our life should be very different than it was before. If we believe in Jesus as Lord, we will:

- 1. Love God with all our heart and love other people.
- 2. Dedicate the rest of our life to following Him as our Lord
- 3. Be His disciple, and allow Him to teach us and lead us into all truth
- 4. Fellowship with Him by reading His word, meditating on His word, talking to Him, listening for a response, and by praising and worshipping Him.
- 5. Study His word, commands, and actions so that we will know what He wants us to do.
- 6. Obey His word, and commandments.
- 7. Do the works that He did and greater
- 8. Make disciples by teaching others to follow Jesus, and helping them along the way
- 9. Trust Him to do what He said He would do; He is not a liar.
- 10. Fear, reverence, honour, and respect Him

In Previous articles I wrote about #1, 2 and 5. It is time now to have a look at #3. If Jesus really is our Lord and we claim to be a Christian, we will be His disciple and allow Him to teach us and lead us into all truth. Jesus said, "And He who does not take his cross and follow after Me is not worthy of Me" (Modern English Version Matt. 10:38). The Greek word that follow is translated from means to follow, to join one as a disciple. Jesus is saying that if we don't follow Him as a disciple, we are not worthy of all that He has provided for us. If we don't follow Him as a disciple, we are not on His side. Here is a similar verse. "He who loves his life will lose it. And he who hates his life in this world will keep it for eternal life. If anyone serves Me, he must follow Me. Where I am, there will My servant be also. If anyone serves Me, the Father will honor him" (John 12:25-26). In this passage Jesus is saying that if we are His servants we will follow Him, He will be with us, and God will honor us. It is also important to notice that in order to follow Him we must give up our own way of life and live for Him instead. You might ask, "How can I follow Him now that He ascended up to Heaven?" Well, that is a good question, however the answer is simple.

We follow Him by studying His teachings and actions that are recorded in the Bible, and by doing what He did, taught, and commanded. The Bible is the written Word of God. It is truth. Look at John 8:31-32: "Then Jesus said to those Jews who believed Him, "If you remain in My word, then you are truly My disciples. You shall know the truth, and the truth shall set you free." Another way we can follow Him now is by allowing Him to lead us by the Holy Spirit whom Jesus promised to send. Jesus said: "But the Counselor, the Holy Spirit, whom the Father will send in My name, will teach you everything and remind you of all that I told you" (John 14:26). "But when the Counselor comes, whom I shall send to you from the Father, the Spirit of truth who proceeds from the Father, He will bear witness of Me" (John 15:26). The Holy Spirit is truth and He will teach us truth, which is found in the written Word of God. He will help us to remember and apply The Word of God in our life.
