ALBERTA TAKES STEPS TO SAFELY RETURN TO NORMAL

Provincewide public health measures will be gradually lifted as the fifth wave of COVID-19 subsides and pressure on the health-care system eases.

Alberta will begin a careful and prudent plan to phase out public health measures, starting Feb. 8. The three-step approach will begin with lower-risk activities while maintaining protections for the health-care system, including continuing care facilities.

Beginning Feb. 8 at 11:59 p.m., Alberta will move to step one, which includes the removal of the Restrictions Exemption Program and capacity limits on venues under 500 capacity, including libraries and places of worship, and allows for food and beverage consumption in seated audience settings for large events and entertainment venues. Mandatory masking for children and youth in schools, and for youth aged 12 and under in any setting will end Feb. 13 at 11:59 p.m.



Council Meeting Notes

Committee of the Whole Meeting February 8, 2022

The Alberta Healthy Communities Initiative for Thorsby requested the Council provide a representative for the committee. Councillor Rasch was appointed and recommended to be the Council's representative. Beverly Milroy from AHS, the committee's coordinator and liaison, had a conversation with our CAO and mentioned that the \$20,000 in grant money was to be split between the trails and Taylor Park. Our CFO stated that a search for the money spent was underway and that there was a possible shortfall for trials in the amount of \$3000. The current administration is meeting with Ms. Milroy to determine if the contract was "fulfilled" or "adhered to" or "amended with any changes" and the status of the grant funds.

The CAO provided a draft template for Council reports. The template is for all heads of departments and Council so there is a consistent and coherent form for reporting the information. Councils traditionally provide month end reports as does the administration to inform of their monthly activities. This is necessary to inform and enlighten the residents, businesses, and all taxpayers of the Municipality.

The Council Meeting Procedure Bylaw Amendment Options were discussed, and suggestions were highlighted on Bylaw 2008-08. It was suggested that a new draft revising bylaw 2022-01 be written with the necessary changes for discussion later. All councillors will make notes and changes for bylaw 2008-08 by February 18 and report back at the next COW meeting on February 22, 2022.

Donna Tona, our interim CAO thanked Sandra Raymond for her work with the Christmas Elves. Sandra also thanked the Thorsby fire department, her family, and the many volunteers that supported her with the collection and distribution of the Christmas hampers.

Cindy Van Leest, our interim CFO reported that there was no revenue entered into quick books since July 2021 and the entries didn't match the Great Plains Municipal accounting program. There was mis-coding that did not coincide with the Journal entries. She asked the auditors for an extension until she sorts through and organizes both sets of books. Municipal Affairs will be notified of the delay. All department heads will bring forward their budgets for the CFO and on March 6th Council will meet to discuss the budget and establish the mill rate.



Throughout history there have been people that exploit, enslave and oppress other people. God hates oppression. There are many examples in the Bible were God set people free from the oppression of other people and of the devil. One obvious example is when God delivered the people of Israel out of Egypt. The Hebrews had been oppressed by the Egyptians for four hundred years. Here is what God said to Moses: "Now therefore, the cry of the children of Israel has come to Me. Moreover, I have also seen the oppression with which the Egyptians are oppressing them. Come now therefore, and I will send you to Pharaoh so that you may bring forth My people, the children of Israel, out of Egypt" (Modern English Version Exod. 3:9-10). In the end the children of Israel plundered the Egyptians and God drowned the Egyptian army in the sea. Here is what God said through the prophet Isaiah: "Is not this the fast that I have chosen: to loose the bonds of wickedness, to undo the heavy burdens, and to let the oppressed go free, and break every yoke?" (Isa. 58:6). God even commanded His people to not oppress one another. "You shall not therefore oppress one another, but you shall fear your God. For I am the LORD your God" (Lev. 25:17). Here are some more from Psalms: "The LORD also will be a refuge for the oppressed, a refuge in times of trouble. Those who know Your name will put their trust in You, for You, LORD, have not forsaken those who seek You" (Ps. 9:9-10). "The LORD does righteousness and justice for all who are oppressed" (Ps. 103:6). "Blessed is he who has the God of Jacob for his help, whose hope is in the LORD his God, who made heaven, and earth, the sea, and all that is in them, who keeps faithfulness forever, who executes justice for the oppressed, who gives food to the hungry. The LORD releases the prisoners. The LORD opens the eyes of the blind; the LORD raises those who are brought down; the LORD loves the righteous" (Ps. 146:5-8). This passage states that the Lord punishes oppressors: "Their children also will be as before, and their congregation will be established before Me; and I will punish all who oppress them" (Jer. 30:20). Early on in Jesus' ministry He declared what His mission was: "The Spirit of the Lord is upon Me, because He has anointed Me to preach the gospel to the poor; He has sent Me to heal the broken-hearted, to preach deliverance to the captives and recovery of sight to the blind, to set at liberty those who are oppressed; to preach the acceptable year of the Lord" (Luke 4:18-19). In the book of Acts Peter states what Jesus did while He was here: "God anointed Jesus of Nazareth with the Holy Spirit and with power, who went about doing good and healing all who were oppressed by the devil, for God was with Him" (Acts 10:38). Here is a statement that Jesus made concerning freedom: "Then Jesus said to those Jews who believed Him, 'If you remain in My word, then you are truly My disciples. You shall know the truth, and the truth shall set you free" (John 8:31-32). Here in Ezekiel God is looking for someone to stand up for the oppressed: "The people of the land have used oppression and exercised robbery and have vexed the poor and needy and have oppressed the sojourner wrongfully. I sought for a man among them who would build up the hedge and stand in the gap before Me for the land so that I would not destroy it, but I found no one" (Ezek. 22:29-30). Clearly God wants His people to be free. "Now the Lord is the Spirit. And where the Spirit of the Lord is, there is liberty" (2Cor. 3:17). Do you think God can use truckers? ALBERTA TAKES STEPS TO SAFELY RETURN TO NORMAL

continued from front page

Subsequent steps will see changes to working from home, masking requirements, large venue capacity limits and indoor social gathering limits, with a final step removing isolation requirements and COVID-specific measures in continuing care settings. The lifting of restrictions will progress once pressures on the health-care system have sufficiently eased.

STEP ONE

Effective Feb. 8 at 11:59 p.m.:

- Restrictions Exemption Program (REP) ends, along with most associated restrictions.
- Entertainment venues will continue to have some specific rules in place:
- Restrictions on sale of food and beverages and consumption while seated in audience settings will be removed.
- Restrictions on closing times, alcohol service, table capacity in restaurants and interactive activities will remain in force.
- For all businesses, venues and facilities whether they were previously eligible for the REP or not – capacity limits are removed, except for:
- Facilities with capacity of 500 to 1,000, which will be limited to 500.
- Facilities with capacity of 1,000-plus, which will be limited to 50 per cent.

Effective at 11:59 p.m. on Feb. 13:

- Masks will no longer be required for all children and youth in schools.
- Masks will no longer be required in any setting for children aged 12 and under.

STEP TWO

Effective March 1:

 Any remaining provincial school requirements (including cohorting) will be removed.

- Screening prior to youth activities will no longer be required.
- Capacity limits will be lifted for all venues.
- Limits on social gatherings will be removed.
- Provincial mask mandate will be removed.
- Mandatory work from home removed.

STEP THREE

To be determined based on hospitalization rates continuing to trend downwards COVID-specific measures in continuing care will be removed.

Mandatory isolation becomes a recommendation only. Additional details on all restrictions and measures in place will be released prior to each step at

MLA REPORT

Jobs, jobs, jobs.

That is what Albertans were seeing when they looked at January's Labour Force Survey from Statistics Canada that showed Alberta created 7,000 net new jobs in January, while much of the country saw significant losses.

The report shows Alberta continued to lead Canada with an employment rate of 64.5 percent and a declining unemployment rate. Alberta is one of only five provinces to see such growth and one of only four provinces to see a drop in its unemployment rate.

This data followed a strong year for Alberta that saw nearly 130,000 net new jobs created and our unemployment rate drop to its lowest since before the pandemic began. While modest, January's numbers show a continuation of those trends. Year over year, Alberta's unemployment rate has gone from 10.8 per cent in January of last year to 7.2 per cent last month.

Our people are going back to work. The share of those ages 25 to 54 with jobs—the "prime age employment rate" — exceeded to approximately 85 per cent in January — the highest rate we've seen in seven years.

The January labour numbers also showed very strong numbers for female labour participation. The labour force participation rate for women ages 25 to 54 is now approximately 85 per cent – the highest rate in the history of our province. That is amazing news for our economy.

As the pandemic wanes, Alberta's economic recovery continues to show strong momentum. This is a far cry from when the Notley NDP lost 200,000 jobs with no pandemic. Alberta is starting to look like its old self again as our oil-patch roars and our people go back to work. As many have said, Alberta is starting to get its "swagger back".

Our economy is also continuing to experience strong economic diversification, and I am confident we will continue to see growth in our province as word spreads that Alberta is a business and entrepreneur-friendly jurisdiction with a high quality of life and low cost of living.

Last year, we saw several record-breaking investments in our province, and we are looking forward to even more investment in 2022. The most recent reports show increases in retail sales, restaurant sales, wholesale trade and oil production. Further, the province saw building permits increase by 30 per cent over the past year.

The pandemic has been challenging for so many Albertans, but we will soon be back to normal, at which point our economy will really take-off. I am very excited about the outlook for our province. If we can produce such strong numbers with a pandemic weighing on us, imagine what we will do when we are back to normal. Alberta is coming back, and I am very much looking forward to the days ahead.

Thank you, as always, for your strength and fortitude. I look forward to providing you with more positive updates soon about jobs and Alberta's economic recovery soon.
